

HERITAGE AND INFORMATION GOVERNANCE Records Retention Schedule for Parliamentary Relations

This category covers the University's relationships with parliamentary bodies at corporate level including: parliaments; parliamentary committees; parliamentary officials; members of parliaments; inter-parliamentary bodies. These bodies or individuals may be in the UK or elsewhere. It does **not** cover routine contact relating to a specific function or activity covered elsewhere in the Retention Schedules.

This retention schedule is based on the recommendations made by the Joint Information Systems Committee. The letter indicates the final disposition of each type of record, and applies to original records. Where copies of originals are kept locally, these can be destroyed when these are no longer required.:

A = 1 copy to be transferred to the University Archive. See Retention Schedule Guidelines for further details.

D = Destroyed.

The number following the letter code indicates the period (in years) after which records may be destroyed, and is the minimum retention period required by best practice or legislation. It assumes a new file is opened at the start of each academic, calendar or financial year, and is **always** calculated from the date of the last record in the file.
