## Notes on composition and membership

In accordance with the Higher Education Governance (Scotland) Act 2016, and as provided for in Statute 5 and the Ordinances, the Senate is constituted in such a way that:
(a) more than $50 \%$ of its members are either persons appointed by being elected by the academic Staff from among their own number, or persons appointed by being elected by the Students of the institution from among the Students of the institution; and

The present structure delivers capacity for 75 Senators, comprised of:
18 ex-officio positions;
8 members elected by the Students from the Student body; and
(b) at least $10 \%$ of its members are persons appointed by being elected by the Students of the institution from among the Students of the institution.

50 members elected by the academic Staff from among the academic Staff in Schools.
